

SANITARY PROTOCOL OF THE COMPETITIONS ORGANIZED BY LATVIAN DARTS ORGANIZATION AND ITS MEMBERS

1. APPLICABILITY OF THE PROTOCOL

- **1.1.** The Sanitary protocol of the competitions organized by LATVIAN DARTS ORGANIZATION (hereinafter referred to as "LDO") and its members (hereinafter referred to as "the Protocol") have been developed in relation to the spread of infectious disease Covid-19 caused by coronavirus in the territory of the Republic of Latvia and the associated restrictions.
- **1.2.** The Protocol is intended to be used for mandatory use in all competitions organized by LDO and its members, subject to the conditions laid down in the Protocol, also for specific LDO competitions.
- **1.3.** As regards the application of the Protocol to Baltic, European and international competitions, which are being held in the territory of the Republic of Latvia, the participants undertake to comply with additional requirements, which are being raised on the part of the State and international organizations.
- 1.4. All participants in the competition, in addition to the Protocol, undertake to comply with all applicable laws of the Republic of Latvia, as well as binding international laws, issued in connection with the spread of infectious diseases caused by coronavirus Covid-19. All the requirements regarding the location of spectators, competition participants and organizers at the venues of the competitions organized by LDO and its members shall be fulfilled in accordance with the Regulation No. 360 of June 09, 2020, "Epidemiological Safety Measures for the Containment of the Spread of COVID-19 Infection" issued by the Cabinet of Ministers of the Republic of Latvia.

2. ESSENTIAL REQUIREMENTS FOR THE CONDUCT OF COMPETITIONS ORGANIZED BY LDO AND ITS MEMBERS

- 2.1. In order to ensure compliance with social (physical) distancing and epidemiological security measures in competitions organized by LDO and its members, LDO and/or their members shall carry out the following processing of personal data: given name, surname, contact phone, personal identity number (for non-residents date of birth) and a statement of the state of health of the person. The data of the natural persons shall be indicated in the Statement, which the person fills and signs prior to registration and participation in the relevant competitions and before the entry of competition area. The processing of personal data shall be ensured in compliance with the requirements of the regulatory enactments and shall be processed only for the purposes specified in this Protocol. Processed personal data is stored for 2 (two) months.
- **2.2.** Participation in competitions organized by LDO and its members shall be prohibited if the person has symptoms of respiratory infectious disease (fever, cough, dyspnea), as well as if the person is subject to conditions of self-isolation, quarantine or isolation. When signing the relevant content form (Statement), a person shall certify that he or she does not have the restrictions on participation in the relevant competition specified in this paragraph. In respect of persons younger than 18 years of age, only the legal representative thereof shall be entitled

- to complete the Statement. The person shall be responsible for the violation of this regulation in accordance with the procedures specified in regulatory enactments.
- 2.3. If a person refuses to sign the Statement or a person younger than 18 years of age has come to a competition without a legal representative, LDO or the organizer of the relevant competitions has the right to refuse the person to participate in the competition and to stay at the venue of the competition by expelling the person from the place of the relevant competitions. When at the place of the competition and/or when participating in the relevant competitions, the person shall respect a distance of 2 (two) meters with other persons. This rule is not applicable if the participants are playing or marking the game and/or the persons disrespecting mentioned distance are from one household. The person shall be responsible for the violation of this regulation in accordance with the procedures specified in regulatory enactments.
- **2.4.** The organizers of the competition, as far as possible, will provide all necessary measures to respect distance and to organize the flow of people by providing informative indications of the relevant content.
- **2.5.** When at the place of the competition and/or when participating in the competition, the person must follow the information instructions provided when moving through and around the relevant place of the competition.

3. FINAL PROVISIONS

- **3.1.** If to one of the participants in the competition organized by LDO and/or its members, after the Covid-19 test, it appears to be positive, the participant concerned shall immediately (on the same day as the results of the test) inform LDO and the organizer of the competition concerned.
- 3.2. LDO and/or the organizer of the competition shall immediately, but not later than within 2 (two) days, inform all participants in the competition concerned as well as the Centre for Disease Prevention and Control (CDPC) of the fact that a positive Covid-19 test has been established for the participant/-s. At the same time, LDO and/or the organizer of the competition concerned shall transmit to the competent national authorities all data relating to the other participants in the competition requested.
- **3.3.** The Protocol shall enter into the force immediately, shall apply to competitions organized by LDO and its members from August01, 2020, and shall remain in force until restrictions have been imposed in the Republic of Latvia in relation to the limitation of the spread of infectious disease Covid-19 caused by coronavirus.
